

Kobe Convention Bureau Image data Terms of use

(1) Purpose of use and eligibility for use of image data

Kobe Convention Bureau provides the photos, videos and images on this website free of charge for use by foreign media and meeting organisers, etc. Use of images is limited to use in the creation of materials to introduce Kobe and promote meetings and events held in Kobe such as posters, presentations, websites, magazine articles, promotional videos etc.

Intention to use image data must be reported to the Kobe Convention Bureau prior to use/publication and materials found to be featuring image data from the Kobe Convention Bureau's website or featured in any of the Kobe Convention Bureau's promotional videos should be reported to the Kobe Convention Bureau via email at: info@kcva.or.jp

(2) Copyright, intellectual rights, portrait rights, etc.

Kobe Convention Bureau holds the copyright and intellectual rights for all image data featured on the bureau's website. However, Kobe Convention Bureau does not hold portrait rights, etc. for people, places, etc. depicted in the image data. Kobe Convention Bureau confirms permission for standard use of images in accordance with (1). For permission for use outside of the purposes described in (1), please negotiate directly with the relevant party. We do not and cannot assume responsibility in the event of conflict with a third party over copyright, intellectual rights, etc.

(3) Prohibitions

Kobe Convention Bureau prohibits the following actions with regards to image data.

- 1) Use of data for purposes other than those described in the terms of use.
- 2) Unauthorised reproduction or distribution of image data.
- 3) Use of image data in the production or sale of a website similar to this website.
- 4) Use of image data for CI (corporate identity), VI (visual identity), as a main image for large-scale campaigns (campaigns with television commercials, etc.), partial or complete use of image data in trademarks, trade symbols, service marks or other product displays.

- 5) Use of image data in which the contents or style are dramatically changed; use in the adult entertainment industry; use that is averse to public order and morality; use that may be mistakenly thought to have religious or political motivations; use in defamation or in connection with illegal activities.
- 6) Use in which user may be mistaken to have a collaborative/cooperative relationship with the subject of images; use in which the subject may be thought to be supporting the user.
- 7) Any other use deemed inappropriate by the Kobe Convention Bureau.
